**Introduction**

The Tana River – Witu-Kibaoni-Mpeketoni-Hindi-Magogoni-Lamu port- Manda Island to Mtangawanda Pate Water Project is County Government of Lamu initiative Supported by the County Government. The Project Development Objective is *“to ensure the residents of Lamu have access to clean drinking water and solve the problem of Water shortages across the County.”*

The Project activities will contribute to these objectives by increasing potential capacity in water storage to the residents of Lamu County, Supply of portable water and decrease average household water return distance to less than 1Km, Also provision of clean portable water to the residents of Lamu County.

Residents of Lamu will access water services in project area at a reasonable price compared to the prevailing tariffs.

**SPECIFIC PROCUREMENT NOTICE (SPN)**

This invitation for bids follows the general procurement notice (GPN) for this project

The County Government of Lamu, intends to use internal financial resources to finance a feasibility study for a water supply project consisting of;

- Reliable water source
- Treatment facility
- Gravitation structures
- Energy supply either green energy, National grid or hybrid system( whichever is cost effective considering the initial cost against the running cost)
- Main line from the treatment centre through witu- Kibaoni( Mpeketoni), Hindi, Magogoni, Lamu port, Manda Island, to Mtangawanda in pate Island
- Lamu county government now invites sealed bids from eligible bidders for the execution of the above project.

**Scope of the Assignment**

To improve accountability and efficiency County government of Lamu will contract qualified service providers that will carry a study on the proposed project covering detailed water source assessment,



environmental and social impact assessment, pipeline surveying,



Economic analysis, preliminary design and financial modeling. The outcome will be a project design report complete with bill of quantity, drawings and project profiles to enable the County Government to make a decision on the viability of the project given the findings.

Prospective firm/Consultants shall have relevant professional experience and having worked in a similar project (Water Projects). The interested consultant/firm shall have higher degree in water resources assessment and experience of over 20 years of practice in addition to other requirements.
